# Memories of Shirley - - - From Marilyn Van Ausdall:

Shirley often rode with me to conventions and fall conferences, even to one in St. Louis with Jan and my daughter, Carissa. Shirley was very unassuming and didn't talk a lot about herself. She obviously was very devoted to AAUW and served at the local level in the Kewanee and Galesburg branches before they disbanded, and she joined Monmouth.

She was our faithful treasurer for many years, when it was a much more time-consuming position than it is now. She dealt with a lot of paperwork, whereas now I can easily handle everything online and with a debit card.

Shirley loved cats. From how she talked about her pet kitties, I knew they were lucky to have ended up as her pets. I'm a cat-lover, too, so we also had that in common.

### From Lila Blum:

Shirley's quiet and unassuming manner did not reveal her fierce support for women's rights and causes, particularly in the work of AAUW. For some of our younger members who lacked financial

resources, Shirley paid their dues. Her generosity was unmatched.

## From Jan DeYoung:

I have many memories of Shirley because we spent a lot of time together travelling to state meetings--Fall Conferences, Summer Board meetings, and, of course, state conventions. We were on the AAUW Illinois board together for many years and roomed together frequently. We had lots of "windshield time" as we travelled around the state for meetings. We also attended at least three national conventions together. I can remember particularly the ones in Toledo, Ohio; Columbus, Ohio; after which we both became Life Members of AAUW, and one in Minneapolis, but there may have been another one or two.

We were together at least once in Washington, DC, for a national convention, but we didn't drive together for that one. When she was Regional Director, I believe, she joined the Kewanee branch to try to help them survive, and when the Galesburg branch folded, she joined our branch and helped it become the Monmouth Area branch. Actually, she may have joined our branch as a dual member before that.

Shirley was a dedicated AAUW member. She served on the state board as Treasurer for a couple of terms, and at least one term as Regional Director. I believe she made some significant contributions to AAUW Funds, and I was not surprised to learn that she had left part of her estate to AAUW

Shirley and her husband, Jack, loved to travel. Before I met her, Shirley had been a high school math teacher, both in Ohio and in Galesburg. And she was devoted to her cats. Since she and Jack had no children, her cats became her babies.

## **Public Policy Updates**

Great news from the National Education Association! Majority Leader Chuck Schumer announced today that the Senate will vote to repeal the Government Pension Offset and Windfall Elimination Provision (GPO and WEP)—the unfair penalties that take away Social Security from millions of educators, first responders, and other public service workers. \*

Scheduling a vote by the Senate before the end of 2024 is a major step towards fixing this injustice. The House already passed it by an overwhelming bipartisan vote, 327 to 75. Please call Senators Tammy Duckworth and Dick Durbin right now and urge them to call for a vote and vote yes on HR 82

the Social Security Fairness Act, which would repeal GPO (the Government Pension Offset) and WEP (Windfall Elimination Provision).

Repealing these unjust penalties is not just about giving retirees their full Social Security—benefits they earned. It's also about current and future educators who want to stay in the profession they love and retire with dignity. Urge Biden and Harris to publish the ERA!

In 1923 Alice Paul and Phyllis Eastman cosponsored the Equal Rights Amendment. In 1972 two-thirds of both houses passed it. When 2/3 of both houses and 34 states ratify a constitutional amendment, it is statutorily ready to be published by the U.S. Archivist (Colleen Shogun who was appointed by Biden) who certifies all ratifications in the US. The Archivist must act when the U.S. President tells them to publish an amendment.

The Equal Rights Amendment is currently the 28th Amendment, but it only becomes official when the President asks the U.S. Archivist for it to be published and then it is published.


#### TAKE ACTION NOW!
